What is the purpose of this update?

This document tells you how the Kōura Wealth KiwiSaver Emerging Markets Equities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kōura Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

This Fund provides exposure to emerging markets including Eastern Europe, the Middle East, South America, Africa and Asia including China. The Fund will invest underlying funds to provide this desired exposure. The Fund expects to deliver a negative return once in every 3-4 years

What are the risks of investing?

Risk indicator for the EM Equities Fund¹:



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of year, Lily incurred a loss after fund charges were deducted of \$1,183. (That is 11.83% of her initial \$10,000). Lily also paid \$30 in administration charges. This gives Lily a total loss after tax and charges of \$1,213 for the year.

The fund's exposure to assets denominated in foreign currencies was 98.75%, of which 0% was hedged. This means the fund's unhedged foreign currency exposure was 98.75% of the net asset value of the fund.

Notes

- As the fund started on 23 October 2019, actual returns for the fund are not available until then. To calculate the
 risk indicator for the five-year period ending 30 June 2022, market index returns have been used up to 31
 October 2019 with actual fund returns used for the balance of the period. As a result of those market returns,
 the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
