3. Changes related to the Scheme

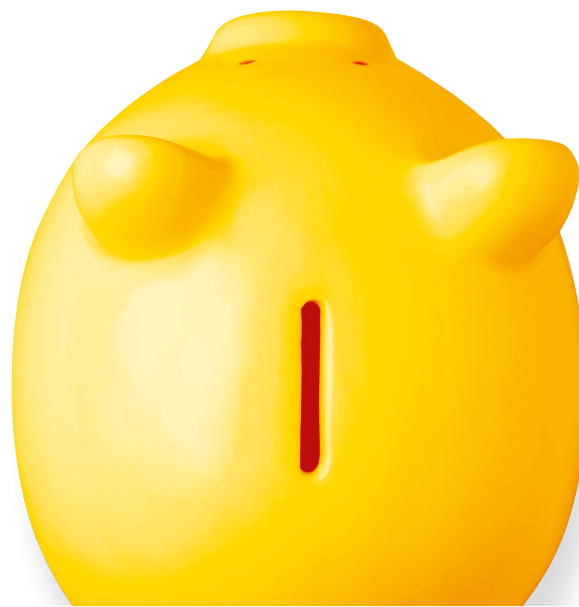
During the period there were no material changes to the Scheme's Trust Deed or the Terms of the Offer of Interests in the Scheme.
