## kōura KiwiSaver Scheme : NZ Equities Fund

Fund Update for the quarter ended **31 December 2022** This update was first made publicly available on 13 February 2023

### What is the purpose of this update?

This document tells you how the koura KiwiSaver Scheme NZ Equities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. koura Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.


#### **Description of this fund**

The Fund provides investors an exposure to the New Zealand share market. The Fund invests in a portfolio of New Zealand listed shares that aim to replicate the Morningstar New Zealand index adjusted to ensure that no single company makes up more than 7% of the underlying index at the start of any month. The Fund expects to deliver a negative return once in every 3-5 years.

#### What are the risks of investing?

Risk indicator for the NZ Equities Fund<sup>1</sup>:





#### How has the fund performed?

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds).


#### Example of how this applies to an investor:

Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of year, Lily incurred a loss after fund charges were deducted of \$989. (That is, 9.89% of her initial \$10,000). Lily also paid \$30 in administration charges. This gives Lily a loss after tax and charges of \$1019 for the year.

#### Notes

- 1. As the fund started on 23 October 2019, actual returns for the fund are not available until then. To calculate the risk indicator for the five-year period ending 31 December 2022, market index returns have been used up to 31 October 2019 with actual fund returns used for the balance of the period. As a result of those market returns, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
- 2. Performance has been calculated from 23 October 2019, when the first investment was made in the fund.
- 3. The bar chart show fund returns after the deduction of fees and taxes, however, the market index returns are shown before any fees or taxes are deducted.
