Fund Update for the quarter ended **31 December 2022** This update was first made publicly available on 13 February 2023.

# What is the purpose of this update?

This document tells you how the koura Wealth KiwiSaver Rest of World Equities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. koura Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

This Fund provides exposure to the share markets of Europe, Australasia, Singapore, Hong Kong, Japan and Israel. The Fund will invest in underlying funds to provide this desired exposure. The Fund expects to deliver a negative return once in every 3-4 years.

# What are the risks of investing?

Risk indicator for the Rest of World Equities Fund<sup>1</sup>:



# **Example of how this applies to an investor:**


Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Lily incurred a loss after fund charges were deducted of \$1,411. (That is 14.11% of her initial \$10,000). Lily was also charged \$30.00 in administration charges. This gives Lily a total loss after tax and charges of \$1,441 for the year.

The top ten investments make up 100% of the fund.

The funds exposure to assets denominated in foreign currencies was 99.43%, of which 50.88% was hedged. This means the fund's unhedged foreign currency exposure was 49.12% of the net asset value of the fund.

#### **Notes**

- As the fund started on 23 October 2019, actual returns for the fund are not available until then. To
  calculate the risk indicator for the five-year period ending 31 December 2022, market index returns
  have been used up to 31 October 2019 with actual fund returns used for the balance of the period.
  As a result of those market returns, the risk indicator may provide a less reliable indicator of the
  potential future volatility of the fund.
- 2. Performance has been calculated from 23 October 2019, when the first investment was made in the fund.
